



# BC TOKENS SALE AGREEMENT

LTD., a company incorporated in Singapore at 176 JOO CHIAT ROAD, #02-02427447, Singapore ("We", "Us", "Boomstarter" or the "Company"). The Purchaser and the Company each are "Party" and, together, the "Parties" to this Agreement agree as follows:

**ACCEPTANCE & CHANGES TO THIS AGREEMENT**

1. Subject to the Boomstarter.network Website Terms of Use, Boomstarter.network Privacy Policy, Platform's AML/KYC Policy and this Agreement, the Company agrees to sell to you and you agree to purchase from Company a specific number of BC Tokens at the price under section 29.1 of this Agreement.
2. By the fact of purchase of BC Tokens from the Company and confirmation of acceptance of this Agreement and/or by clicking on the checkbox "I agree" at the website <https://boomstarter.network> as such actions are a symbol of Purchaser's signature, the Purchaser confirm that he/she/it have read this Agreement carefully and in its entirety and understand that HE/SHE/IT IS CONSENTING TO BE BOUND BY AND IS BECOMING A PARTY TO THIS AGREEMENT AND ANY TERMS OR AGREEMENT INCORPORATED BY REFERENCE AND AGREE THAT THIS AGREEMENT IS ENFORCEABLE LIKE ANY WRITTEN NEGOTIATED AGREEMENT SIGNED BY YOU. The Purchaser may withdraw from his/her/its obligations under this Agreement under conditions in sections 34, 35, 36 of this Agreement or assign his/her/its rights and obligations under this Agreement under conditions in section 37.
3. Unless otherwise stated herein, this Agreement govern only Purchaser's acquisition of Tokens from Boomstarter during the Sale Period. Any use of BC Tokens in connection with providing or receiving Services in the Platform shall be governed primarily by other applicable agreements and policies. The Company may use third party services to process the Token Sale and any rules applicable by third party described in this Agreement to such processing of BC Tokens should also be applicable in addition to this Agreement.
4. This Agreement is intended to fully reflect the terms and conditions of the original agreement between the parties. No provision of this Agreement shall be considered waived unless such waiver is accepted by the party that benefits from the enforcement of such provision by action of a click in a specific check box with the text "I agree" at the Website, which shall be published on the Website in such case. No waiver of any provision in this Agreement, however, will be deemed a waiver of a subsequent breach of such provision or a waiver of a similar provision. In addition, a waiver of any breach or a failure to enforce any term or condition of this Agreement will not in any way affect, limit, or waive a party's rights hereunder at any time to enforce strict compliance thereafter with every term and condition hereof.
5. The Purchaser acknowledges and accepts that this Agreement may be modified, changed, supplemented, updated at any time without prior written notice, at sole discretion of Boomstarter. Your continued use of the BC Tokens after any amendments or alterations of this Agreement shall constitute Your consent hereto and acceptance hereof. At any case, the date of the most recent amendments and alterations will be indicated at the top of this Agreement. If the Purchaser does not agree to such revised terms of the Agreement he/she/it must stop using this BC Tokens and may withdraw from his/her/its obligations under this Agreement under conditions in sections 34, 35, 36 of this Agreement or assign his/her/its rights and obligations under this Agreement under conditions in section 37.

**INTERPRETATION**

6. In this Agreement unless the opposite is clear from the context the following rules of interpretation apply:

- 6.1. Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular;
  - 6.2. Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
  - 6.3. References to clauses and schedules are to the clauses and schedules of this Agreement and references to paragraphs are to paragraphs of the relevant schedule;
  - 6.4. A reference to any party shall include that party’s personal representatives, successors and permitted assigns.
  - 6.5. All references to a person include firms, companies, government entities, trusts and partnerships or other or unincorporated body (whether or not having separate legal personality);
  - 6.6. The term 'including' does not exclude anything not listed;
  - 6.7. A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time;
  - 6.8. A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.
  - 6.9. A reference to writing or written includes fax and e-mail.
  - 6.10. Any obligation on a party not to do something includes an obligation not to allow that thing to be done.
  - 6.11. Any words following this Agreement including, include, in particular, for example or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding or following that agreement.
  - 6.12. Headings of sections are for convenience only and shall not be used to limit or construe such sections. All the sections in this Agreement shall survive any termination or expiration of this Agreement.
7. The following definitions and rules of interpretation apply in this Agreement:

<b>“Purchaser” or “You”</b>	A party to this Agreement which is any person, who uses the Website for purchase of BC Tokens via account on the Website. The Company reserves its right to set forth at any time and upon its own discretion special eligibility conditions or other requirements to certain BC Tokens Purchasers.
<b>“Boomstarter” or “Company”, “We”, “Us”</b>	Boomstarter PTE. LTD., a company incorporated in Singapore at 176 JOO CHIAT ROAD, #02-02427447, Singapore, which issues and offer BC Tokens for sale under this Agreement.
<b>“Accompanying Documents”</b>	Other BC Tokens Sale regulatory documents accompanying and detailing this Agreement, being inalienable part hereof and published on the Website (including but not limited to Privacy Policy, Terms of Use, AML/KYC policy). In case of any discrepancies between Accompanying Documents and the Agreement, the latter shall apply. Materials, such as the White Paper and others, published in the Website or elsewhere, are not binding and do not – unless explicitly referred to herein – form part of this Agreement, and are of descriptive nature only and cannot be considered as any type of Accompanying documents.
<b>“Affiliate”</b>	Any person or entity that has any relation to the Boomstarter, including, but not limited to partners, employees, agents and contractors of the Company.

<p><b>“Applicable Exchange Rate”</b></p>	<p>The volume-weighted average price of Ethereum (ETH) or Bitcoin (BTC) or any other accepted cryptocurrency in U.S. Dollars (USD) at Coinmarketcap (available in the Internet via <a href="https://coinmarketcap.com">https://coinmarketcap.com</a>) at the Effective Date in this Agreement.</p>
<p><b>“Boomstarter Platform” or “Platform”</b></p>	<p>A digital platform operated by Boomstarter PTE. LTD., a company incorporated in Singapore at 176 JOO CHIAT ROAD, #02-02427447, Singapore, designated for reward based crowdfunding in cryptocurrency.</p>
<p><b>“Cryptocurrency”</b></p>	<p>Digital cryptographic representation of virtual currency, represented by Ethereum (ETH), Bitcoin (BTC) and any other type of cryptocurrency accepted during the Token Sale by the Company under the section 27 of this Agreement used by Purchasers for acquisition of BC Tokens.</p>
<p><b>“Intellectual Property Rights”</b></p>	<p>Any invention, patent, utility model right, copyright and related right, registered design, unregistered design right, trade mark, trade name, internet domain name, design right, design, service mark, database rights, topography rights, rights in get-up and trade dress, rights in goodwill or to sue for passing off and any other rights of a similar nature or other industrial or intellectual property rights owned or used by the Boomstarter in any part of the world whether or not any of the same is registered (or capable of registration), including applications and the right to apply for and be granted, extensions or renewals of and rights to claim priority from, such rights and all equivalent or similar rights or protections which subsist now or will subsist in the future.</p>
<p><b>“BC Token” or “Token”</b></p>	<p>Digital cryptographic token, which is a software digital product (not being cryptocurrency), created and issued by the Company as a cryptographically secured representation of the right to exchange BC for services on the Platform, for example to support any project in crowdfunding or purchase Miner Pro status.</p>
<p><b>“BC Token Sale”</b></p>	<p>An offering, public sale and distribution of BC Tokens to eligible Purchasers held during a limited period of time specified in section 27 of this Agreement.</p>

<p><b>“Smart Contract” or “Smart Contract System”</b></p>	<p>Digital computer protocol intended to facilitate, verify and enforce the negotiation and purchase of BC Tokens by Purchaser.</p>
<p><b>“Website”</b></p>	<p>A group of interrelated websites owned and operated by Boomstarter PTE. LTD., a company incorporated in Singapore at 176 JOO CHIAT ROAD, #02- 02427447, Singapore , available in the Internet via address: <a href="https://boomstarter.network">https://boomstarter.network</a> and special application based on blockchain technology.</p>

8. Certain statements in this Agreement and informational documents of the Company constitute “forward-looking information” under applicable laws. Except for statements of historical fact, information contained herein may constitute forward-looking statements. When used in this Agreement, the words “may,” “will,” “should,” “project,” “anticipate,” “believe,” “estimate,” “intend,” “expect,” “continue,” and similar expressions or the negatives thereof are generally intended to identify forward-looking statements. Forward looking statements are not guarantees of future performance, and undue reliance should not be placed on them. Such forward-looking statements necessarily involve known and unknown risks and uncertainties, which may cause actual performance on Company’s obligations, market projections and financial results in future periods to differ materially from any projections of future performance or result expressed or implied by such forward looking statements. Although forward-looking statements contained herein are based upon what management believes may be reasonable assumptions, forward-looking statements may prove to be inaccurate, as actual results and future events could differ materially from those anticipated in such statements. No provision of this Agreement shall be considered waived unless such waiver is accepted by the party that benefits from the enforcement of such provision by action of a click in a specific button with the text “Sign Up” or “I agree” on the Website, which shall be published on the Website in such case. No waiver of any provision in this Agreement, however, will be deemed a waiver of a subsequent breach of such provision or a waiver of a similar provision. In addition, a waiver of any breach or a failure to enforce any term or condition of this Agreement will not in any way affect, limit, or waive a Party’s rights hereunder at any time to enforce strict compliance thereafter with every term and condition hereof. ELIGIBLE PURCHASERS

10. By purchasing BC Tokens each Purchaser covenants, represents, and warrants that (under the Applicable Law and law of the country of Purchaser’s residence):

10.1. he/she/it is of an age of majority to enter into this Agreement (at least 18 years of age), meets all other eligibility criteria and residency requirements, and is fully able and legally competent to use the Website, enter into agreement with the Boomstarter and in doing so will not violate any other agreement to which he/she/it is a party;

10.2. he/she/it has necessary and relevant experience and knowledge to deal with cryptographic Tokens, cryptocurrencies and Blockchain-based systems, as well as full understanding of their framework, and is aware of all the merits, risks and any restrictions associated with cryptographic Tokens (their purchase and use), cryptocurrencies and Blockchain-based systems, as well as knows how to manage them, and is solely responsible for any evaluations based on such knowledge;

10.3. if he/she/it is a corporation or other legal entity, he/she/it has the right, power and authority to enter into this Agreement on behalf of the corporation or other legal entity and

bind them to this Agreement;

10.4. Is not a foreign or domestic PEP.

10.5. he/she/it will not be using the Website for any illegal activity, including but not limited to money laundering and the financing of terrorism;

10.6. Purchaser created an Account on the Website and accepted Boomstarter Terms of Use, Boomstarter Privacy Policy and Boomstarter AML/KYC Policy.

11. Purchaser is only allowed to purchase BC Tokens if and by buying BC Tokens he/she/it covenant, represent, and warrant that you are neither a citizen, resident or tax resident of the United States of America (hereinafter referred to as the "U.S." or U.S. Person under definition of Rule 902 of the U.S. Securities Act of 1933), Canada, Singapore, New Zealand, Iceland, Thailand, Afghanistan, Burundi, Balkan, Burma (Myanmar), Cote d'Ivoire, Cuba, Democratic Republic of Congo, Democratic Peoples' Republic of Korea, Iran, Iraq, Liberia, Lebanon, Libya, North Korea, Rwanda, Sierra Leone, Somalia, Sudan, Syria, Tanzania, Uganda, Zaire, Zimbabwe and countries or territories or individuals under the sanctions of the United Nations or the European Union (the list is available at: [https://eeas.europa.eu/sites/eeas/files/restrictive\\_measures-2017-08-04.pdf](https://eeas.europa.eu/sites/eeas/files/restrictive_measures-2017-08-04.pdf)) or countries where cryptocurrency is prohibited;

12. Boomstarter prohibits acceptance of funds by any persons or entities that are acting, directly or indirectly:

12.1. in contravention of any national or international laws and regulations, including anti-money laundering regulations or conventions;

12.2. on behalf of terrorists or terrorist organizations;

12.3. for a PEP or any member of a PEP's family or any close associate of a PEP, unless the Company, after being specifically notified in writing that the Purchaser is such a person, conducts further due diligence, and determines that such acquisition shall be permitted; or

12.4. for a foreign shell bank .

#### **DESCRIPTION OF BC TOKENS**

13. BC Tokens are digital cryptographic tokens, which are software digital products (not being cryptocurrency), created and issued by the Company as a cryptographically secured representation of the right to exchange BC for services on the Platform, for example to support any project in crowdfunding or purchase Miner Pro status.

14. and which give the Purchaser access to certain features on the Platform.

15. There will be in total 36 000 000 (thirty six millions) BC Tokens available ("Total BC Tokens Number"). Boomstarter shall not create additional BC Tokens at any time after the initial token release. All BC Tokens unsold during the Token Sale shall be burnt.

16. BC Tokens shall be distributed in the following manner:

16.1. 80% BC Tokens shall be distributed to the Purchasers during the Token Sale;

16.2. 4% BC Tokens shall be distributed to BC Tokens to project advisors and partners;

16.3. 15% BC Tokens shall be retained by Boomstarter development team;

16.4. 1% BC Tokens shall be reserved for social network competition.

17. BC Tokens carries no rights, express or implied, other than those, set out herein, subject to Boomstarter development of the project. In particular, BC Tokens holders shall not have any influence in the development or governance of Boomstarter, and BC Tokens do not represent or constitute any ownership right or stake, share or security or equivalent rights or any right to receive future revenue shares, or any other form of participation in or relating to Boomstarter.

18. Purchaser acknowledge and accept that BC Tokens do not represent or constitute:

18.1. any ownership right or stake, share, equity, security, commodity, Boomstarter, debt instrument or any other financial instrument or investment carrying equivalent rights;

18.2. any right to receive future revenues, shares or any other form of participation or governance right from, in or relating to Company and Platform;



18.3. any form of money or legal tender in any jurisdiction, nor do they constitute any representation of money (including electronic money).

19. Any potential future use of BC Tokens in connection with the provision or receipt of services on Boomstarter Platform, shall be subject to and governed by such other applicable terms, conditions and policies relating to the use of each such service or Platform. Such terms and conditions regulating the use of the Platform shall be made available to the Platform users.

20. BC Tokens are not consumer products and its holders accepts explicitly and agree to it that they are not covered by the consumer protection regulation of any jurisdiction.

21. Purchaser is responsible for implementing all reasonable and appropriate measures for securing his/her/its cryptographic wallet, vault or other storage mechanism he/she/it use to send payment to Company and to receive and store BC Tokens that are issued to him/her/it by the Boomstarter smart contract, including any requisite private key(s) or other credentials necessary to access such storage mechanism(s). If Purchaser's private key(s) or other access credentials are lost, he/she/it may lose access to BC Tokens. Company shall not be responsible for any security measures relating to Purchaser's receipt, possession, storage, transfer or potential future use of BC Tokens nor shall we be under any obligation to recover or return any BC Tokens and Company hereby excludes (to the fullest extent permitted under Applicable law) any and all liability for any security breaches or other acts or omissions which result in Purchaser's loss of (including loss of access to) BC Tokens issued to Purchaser during the Token Sale.

### **ACKNOWLEDGEMENT AND ASSUMPTION OF RISKS RELATED TO BC TOKENS**

22. Purchaser understand that BC Tokens, blockchain technology, Ethereum, Ether and other associated and related technologies are new and untested and outside of Boomstarter's exclusive control and adverse changes in market forces or the technology, broadly construed, may prevent or compromise Boomstarter's performance under this Agreement.

23. Purchaser agree that no other party (including, without any limitation) may be held liable for any loss arising out of, or in any way connected with Purchaser's participation in the BC Tokens-sale, or receiving and holding Tokens or such risk.

24. Purchaser also acknowledge that prior to receiving BC Tokens he have been warned of the following risks, associated with the Website, the Boomstarter Tokens, the Platform and other relevant technologies mentioned herein:

24.1. Legal risks regarding securities regulations

There is a risk that in some jurisdictions the BC Tokens might be considered to be a security, or that it might be considered to be a security in the future. Boomstarter does not give warranties or guarantees that BC Tokens are not a security in all jurisdictions. Each holder of BC Tokens shall bear its own legal or financial consequences of BC Tokens being considered a security in their respective jurisdiction.

Every Purchaser is bound to check if acquisition and disposal of BC Tokens is legal in his jurisdiction, and by accepting this Agreement, each Purchaser undertakes not to use BC Tokens if such usage is not be legal in the relevant jurisdiction. If Purchaser establishes that the use of BC Tokens under this Agreement is not legal in his jurisdiction, You should not use the BC Tokens, not acquire them and should immediately stop using or possessing them if such case arises.

Acquiring cryptographic Tokens for personal possession and exchanging them for other cryptographic Tokens will most likely continue to be scrutinized by various regulatory bodies around the world, which has so far given mixed reactions and regulatory impact. The legal ability of Boomstarter to provide BC Tokens and the Platform jurisdictions may be eliminated by future regulation or legal actions. In the event, it turns out with a high degree certainty that BC Tokens are not legal in certain jurisdiction, Boomstarter will either:

- a) cease operations in that jurisdiction, or
- b) adjust BC Tokens and the Platform in a way to comply with the regulation should that be possible and viable.

#### 24.2. Risks associated with Ethereum

BC Tokens are based on Ethereum blockchain. As such, any malfunction, unintended function or unexpected functioning of the Ethereum protocol may cause the BC Tokens to malfunction or function in an unexpected or unintended manner. Ether, the native unit of account of the Ethereum may itself lose value in ways similar to BC Tokens, and also other ways. More information about the Ethereum is available at <http://www.ethereum.org>.

#### 24.3. Risk of unfavorable regulatory action in one or more jurisdictions

Blockchain technologies have been the subject of scrutiny by various regulatory bodies around the world. The functioning of the Ethereum network and associated blockchain networks and BC Tokens could be impacted by one or more regulatory inquiries or actions, including but not limited to restrictions on the use or possession of digital Tokens like BC Tokens, which could impede or limit their existence, permissibility of their use and possession, and their value.

#### 24.4. Risk of theft and hacking

Hackers or other groups or organizations may attempt to interfere with Your Third-party Wallet, the Website or the availability of BC Tokens and Digital Assets in any number of ways, including without limitation denial of service attacks, Sybil attacks, spoofing, smurfing, malware attacks, or consensus-based attacks. You hereby agree that Boomstarter shall have no liability for any such loss the Purchaser incur.

#### 24.5. Risk of security weaknesses in the Website and/or BC Tokens source code or any associated software and/or infrastructure

There is a risk that the Website and BC Tokens may unintentionally include weaknesses or bugs in the source code interfering with the use of or causing the loss of BC Tokens.

#### 24.6. Risk of weaknesses or exploitable breakthroughs in the field of cryptography Advances in cryptography, or technical advances such as the development of quantum computers, could present risks to cryptocurrencies, Ethereum, BC Tokens, the Platform, which could result in the theft or loss of BC Tokens.

#### 24.7. Risk of mining attacks

As with other decentralized cryptocurrencies, Ethereum blockchain, which is used for the BC Tokens, is susceptible to mining attacks, including but not limited to double-spend attacks, majority mining power attacks, "selfish-mining" attacks, and race condition attacks. Any successful attacks present a risk to the BC Tokens, expected proper execution and sequencing of BC Tokens, and expected proper execution and sequencing of Ethereum contract computations in general. Despite the efforts of Boomstarter and Ethereum Foundation, the risk of known or novel mining attacks exists. Mining Attacks, as described above, may also target other blockchain networks, with which the BC Tokens interact with and consequently the BC Tokens may be impacted in that way to the extent, described above.

#### 24.8. Risk of low or no liquidity

Even though there are currently online service available, which enable possibility of exchange of cryptographic tokens between themselves, and also, some of them enable exchange of cryptographic tokens for fiat money, there are no warranties and/or guarantees given that BC Tokens will be listed or made available for exchange for other cryptographic tokens and/or fiat money, and no guarantees are given whatsoever with the capacity (volume) of such potential exchange. It shall be explicitly cautioned, that such exchange, if any, might be subject to poorly understood regulatory oversight, and Boomstarter does not give any warranties in regard to any exchange services providers. Purchasers might be exposed to fraud and failure. In any case, Boomstarter will not enable exchange of BC Tokens for other cryptographic tokens or for fiat currency. Purchaser may not at any given time be able to

acquire or dispose of its BC Tokens due to lack of liquidity.

#### 24.9. Risk of loss of value

Value of BC Tokens may fluctuate and their Purchasers might suffer loss in value of such acquired tokens. There might be different reasons that would cause unfavorable fluctuations of the value of the BC Tokens.

#### 24.10. Risk of uninsured losses

BC Tokens are unlike bank accounts or accounts at some other financial institutions and are entirely uninsured.

#### 24.11. Risk of malfunction in the Ethereum network or any other blockchain

It is possible that the Ethereum network or any other network, to which the BC Tokens are interacting with, malfunctions in an unfavorable way, including but not limited to one that result in the loss of BC Tokens

#### 24.12. Internet transmission risks

Purchaser acknowledge that there are risks associated with using the BC Tokens including, but not limited to, the failure of hardware, software, and Internet connections. Purchaser acknowledge that Boomstarter shall not be responsible for any communication failures, disruptions, errors, distortions or delays You may experience when using the Website and BC Tokens, howsoever caused.

#### 24.13. Unanticipated risks

Cryptocurrencies and blockchains are new and untested technology. In addition to the risks set forth here, there are risks that Boomstarter cannot foresee and it is unreasonable to believe that such risks could have been foreseeable. Risks may further materialize as unanticipated.

#### 24.14. Insufficient interest in Boomstarter, the Platform and BC Tokens

It is possible that Boomstarter, BC Tokens or Platform will not be used by a large number of individuals, businesses and other organizations and that there will be limited public interest in the creation and development of its functionalities. Such a lack of interest could impact the development of the Platform and usage of BC Tokens on it.

#### 24.15. BC Tokens and the Platform, as developed, may not meet the Purchaser's expectations

The Platform is currently under development and may undergo significant changes before release. The Purchaser's expectations regarding the form and functionality of the Platform and BC Tokens may not be met upon release of new Website, deployment of the Platform, additional products and services for any number of reasons, including a change in the design and implementation plans and execution of the implementation of BC Tokens.

### **PROHIBITED ACTIVITIES**

25. You are prohibited from violating any law, statute, ordinance or regulation in our registered jurisdiction as well as your country or residency by using BC Tokens.

26. You may not use your BC Tokens to engage in the following categories of prohibited activity and you confirm that you will not use BC Tokens to do any of the following: Engage in a transaction involving the proceeds of any unlawful activity;

26.1. Defraud or attempt to defraud Boomstarter or its affiliates;

26.2. Provide false, inaccurate or misleading information;

26.3. Infringe upon Company's or any third party's copyright, patent, trademark, or intellectual property rights;

26.4. Take any action that imposes an unreasonable or disproportionately large load on infrastructure of Boomstarter, or detrimentally interfere with, intercept, or expropriate any system, data, or information;

26.5. Transmit or upload any material to the Platform that contains viruses or malware or any other harmful or deleterious programs;

26.6. Otherwise attempt to gain unauthorized access to the Platform and Website, computer

systems or networks connected to the Website, through password mining or any other means;

27. Company reserves the right at all times to monitor, review, retain and/or disclose any information as necessary to satisfy any applicable law, regulation, legal process or governmental request. Boomstarter reserves the right to cancel and/or suspend your Account and usage of BC Tokens immediately and without notice if Company determine, in its sole discretion, that your Account and usage of BC Tokens is associated with prohibited use, and/or a prohibited business, and or illegal activity under Applicable law.

**PAYMENT PROCEDURE**

No third-party website or a different provider except ones listed on the Website allowed and has not been in any way supported, engaged, authorized or BCrsed by Boomstarter and have no relationship in any way with Boomstarter. The only official and authorized website and BC Tokens distribution provider is the Website available in the Internet via boomstarter.network The Purchaser must ensure that the URL of your web browser indicates that it is using a hypertext transport protocol secure connection ("https") and that the domain name is correct. All payments in cryptocurrency shall be made at Company's Smart Contract Address.

31. Payments in fiat currency are not accepted during the Token Sale. In case of the Purchaser wants to purchase BC Tokens for fiat currency he/she/it should contact boomstarter.network via support@boomstarter.network and receive information about third party services which accept fiat currency in exchange for virtual currency.

**DELIVERY OF BC TOKENS**

32. If you prefer to remain a holder, please note that you will be deemed to have waived any further right to demand return of your money.

**WITHDRAWAL**

36. In order to cancel the purchase during the reimbursement period Purchaser shall contact the Company in the writing form via support@boomstarter.network with letter of demand for the cancellation and withdrawal of funds with documentary proof of purchase of BC Tokens during the token sale and identification documents required under Boomstarter AML/KYC Policy.

**RETURNING OF TOKENS**

37. After the consideration of the request by the Company and confirmation of the Purchase and request for the refund, Purchaser shall provide a cryptographic wallet address to which he demand a transfer of reimbursed fund. In no event shall the reimbursement

40. Any commissions, gas, mining fees and expenses for refund of payment amount are not reimbursed by the Company.

### **INTELLECTUAL PROPERTY**

41. Boomstarter has valid, unrestricted and exclusive ownership of rights to use the patents, trademarks, trademark registrations, trade names, copyrights, know-how, technology and other intellectual property necessary to the conduct of selling of the BC Tokens and its commercial activities generally. This Agreement in no way shall entitle any Purchaser for any intellectual property of the Boomstarter, including the intellectual property rights for the Website and all text, graphics, Purchaser`s account interface, visual interface, photographs, trademarks, logos, artwork, and computer code, design, structure, selection, coordination, expression and other content connected to the Website. Arrangement of such content is owned by the Boomstarter and its affiliates and is protected by national and international intellectual property rights protection laws. Other product and service names on the Website, Platform and informational materials might be trademarks of other companies.

42. Unless otherwise stated, the content and information on the Website are the property of Boomstarter and its affiliates with exception of trademarks, company names of other companies. You may not download, reproduce, or retransmit any information, other than for non-commercial individual use. You are granted a limited, non-transferable, revocable license to view and copy the information from the Website and Platform solely for personal use only.

43. All intellectual property rights comprised in the information, text, graphics, logos, images, audio clips, data compilations, scripts, software, technology, sound or any other materials or works found in the Website and Platform shall vest in and remain property of Boomstarter and its affiliates. You are permitted to download and print such materials from the Website for personal and non-commercial use provided that You do not breach this Agreement.

44. Boomstarter and its affiliates retain all intellectual property rights, mostly, but not limited, to copyright, over the source code forming BC Tokens, smart contract of the BC Token Sale, Website and Platform.

45. There are no implied licenses under this Agreement and the Company reserves any rights not expressly granted to the Purchaser hereunder.

46. If for the purpose of any intellectual property right registration of the Boomstarter, any documentary submission or any other action is required from the Purchaser, he/she/it must provide the Company with the respective assistance.

### **REPRESENTATIONS AND WARRANTIES**

47. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW AND EXCEPT AS

OTHERWISE SPECIFIED IN A WRITING BY BOOMSTARTER, BC TOKENS ARE SOLD ON AN "AS IS" AND "AS AVAILABLE" BASIS WITHOUT WARRANTIES OF ANY KIND, AND BOOMSTARTER EXPRESSLY DISCLAIM ALL IMPLIED WARRANTIES AS TO THE TOKENS, INCLUDING, WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT; BOOMSTARTER DOES NOT REPRESENT OR WARRANT THAT THE TOKENS ARE RELIABLE, CURRENT OR ERROR-FREE, MEET YOUR REQUIREMENTS, OR THAT DEFECTS IN THE TOKENS WILL BE CORRECTED; AND BOOMSTARTER CANNOT AND DOES NOT REPRESENT OR WARRANT THAT THE TOKENS OR THE DELIVERY MECHANISM FOR TOKENS ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS.

48. By purchasing the BC Tokens the Purchaser represent and warrant that he has read and understand this Agreement and all Accompanying Documents in full and he fully agree with the information about the functionality of BC Token, usage, storage, transmission mechanisms and other material characteristics of the BC Tokens, blockchain technology, blockchain-based software systems and their risks, and appreciates the risks and implications of purchasing the BC Tokens.

49. You understand that the BC Tokens confer only the right to exchange BC Token for services on the Platform and which give the Purchaser access to certain features on the Platform and confer no other rights of any form with respect to the Company or its corporate affiliates, including, but not limited to, any voting, distribution, redemption, liquidation, proprietary (including all forms of intellectual property), or other financial or legal rights. You are not purchasing BC Tokens for any other uses or purposes, including, but not limited to, any investment, speculative or other financial purposes.

50. The Purchaser fully understands, realizes and agrees that the BC Tokens are created on a blockchain and are designed to be used in the manner described in Accompanying Documents Purchaser agree to accept consequences of possible regulation of BC Tokens in jurisdiction of the Company incorporation and agree to provide all documents requested from Boomstarter in case of such regulation in order to comply with all requirements demanded from governmental bodies of jurisdiction of Company incorporation.

51. Boomstarter does not warrant or represent that any information on the Website is accurate or reliable or that the Website will be free of errors or viruses, that defects will be corrected, or that the service or the server that makes it available is free of viruses or other harmful components. Boomstarter shall not be liable for uninterrupted availability of the Platform for use of BC Tokens at all times, in all countries and/or all geographic locations, or at any given time.

52. ### **TAXATION**

60. The Purchaser bears the sole responsibility to determine if the purchase of BC Tokens with BTC, LTC, ETH or any other cryptocurrency or the potential appreciation or depreciation in the value of BC Tokens over time has tax implications for the Purchaser in the Purchaser's home jurisdiction. By purchasing BC Tokens and to the extent permitted by law, the Purchaser agrees not to hold any of the Company, its affiliates, shareholders, directors or advisors liable for any tax liability associated with or arising from the purchase of BC Tokens.

61. Purchaser is solely responsible for withholding, collecting, reporting, paying, settling and/or remitting any and all taxes to the appropriate tax authorities in such jurisdiction(s) in which Purchaser may be liable to pay tax. Company shall not be responsible for withholding, collecting, reporting, paying, settling and/or remitting any taxes (including, but not limited to, any income, capital gains, sales, value added or similar tax) which may arise from Purchaser's acquisition of BC Tokens under or in connection with this Agreement.

### **INDEMNIFICATION**

62. To the extent allowable pursuant to Applicable Law, the Purchaser shall indemnify, defend, and hold the Company and/or its subsidiaries, affiliates, directors, officers, employees, agents, successors, and permitted assignees harmless from and against any and all claims, damages, losses, suits, actions, demands, proceedings, expenses, and/or liabilities (including but not limited to reasonable attorneys' fees incurred and/or those necessary to successfully establish the right to indemnification) filed/incurred by any third party against the Company arising out of a breach of any warranty, representation, or obligation hereunder.

### **CIRCUMSTANCES BEYOND THE CONTROL OF EITHER PARTY**

63. The Purchaser shall not have any claim of any nature whatsoever against Boomstarter for any failure by Company to carry out any of its obligations under this Agreement as a result of causes beyond its control, including but not limited to power failure, Internet service provider failure, acts of God, epidemic, pandemic, civil unrest, fire, flood, droughts, storms, earthquakes, collapse of buildings, explosion or accident, acts of terrorism, acts of war, governmental action, any law or any action taken by a government or public authority, including without limitation imposing an export or import restriction, quota or prohibition, or any other event that is beyond the absolute and direct control of the Boomstarter.

**SEVERABILITY**

64. If any term, provision, covenant or restriction of this Agreement is held by a court of competent jurisdiction to be invalid, illegal, void or unenforceable, the remainder of the Agreement, provisions, covenants and restrictions set forth herein shall remain in full force and effect and shall in no way be affected, impaired or invalidated, and the parties hereto shall use their commercially reasonable efforts to find and employ an alternative means to achieve the same or substantially the same result as that contemplated by such term, provision, covenant or restriction. It is hereby stipulated and declared to be the intention of the parties that they would have executed the remaining terms, provisions, covenants and restrictions of the Agreement without including any of such that may be hereafter declared invalid, illegal, void or unenforceable.

**APPLICABLE LAW**

65. All questions concerning the construction, validity, enforcement and interpretation of this Agreement shall be governed by and construed and enforced in accordance with the laws of Singapore.

**DISPUTE RESOLUTION**

66. To resolve any dispute, controversy or claim between Parties arising out of or relating to this Agreement or the breach thereof, the Parties agree first to negotiate the issue in good faith for a period of not less than thirty (30) days following written notification of such controversy or claim to the other Party.

67. If the negotiations do not resolve the dispute, controversy or claim to the reasonable satisfaction of all Parties during such period, then the Parties irrevocably and unconditionally submit to the respective claim to the binding arbitration administered by Singapore International Arbitration Centre ("SIAC") in accordance with the Arbitration Rules of the Singapore International Arbitration Centre ("SIAC Rules") for the time being in force which rules are deemed to be incorporated by reference in this clause, composed of one arbitrator, in English language, in writing on the basis of the documents submitted.

68. Any dispute arising out of or related to this Agreement which cannot be resolved by negotiations is personal to Purchaser and Boomstarter and shall be resolved solely through individual arbitration and will not be brought as a class arbitration, class action or any other type of representative proceeding. There will be no class arbitration or arbitration in which an individual attempt to resolve a dispute as a representative of another individual or group of individuals. A dispute cannot be brought as a class or other type of representative action, whether within or outside of arbitration, or on behalf of any other individual or group of individuals.

**TERMINATION**

69. Boomstarter reserve the right, without notice and at its sole discretion, to terminate this Agreement or suspend the Purchaser's right to access the Website, including (but not limited to) in case of Purchaser's breach of this Agreement or if the Boomstarter believes You have committed fraud, negligence or other misconduct. The Purchaser may terminate this Agreement without notice by discontinuing use of the Website. All rights granted to the Purchaser under this Agreement will immediately be revoked upon our termination of this Agreement or Boomstarter suspension of the Your access to the Website. In the event of any circumstances beyond the control of the Parties, breach of this Agreement, or any other event that would make provision of services commercially unreasonable for Boomstarter, the Company may, in its own discretion and without liability to the Purchaser, with or without prior notice, suspend the Purchaser's access to all or a part of Boomstarter's Platform. Boomstarter may terminate the Purchaser's access to the Website in its sole discretion,

immediately and without prior notice, and delete all related information and files related to such Purchaser without liability to You, including, for instance, in the event that the Purchaser breach any term of this Agreement. In the event of termination, Boomstarter will attempt to return any funds stored in Your smart contract number not otherwise owed to Boomstarter, unless Boomstarter believes the Purchaser has committed fraud, negligence or other misconduct.

#### **OTHER CONDITIONS**

70. Only English versions of any Company's communications are considered official. The English version of this Agreement shall prevail in case of differences in translation.

71. Any notice or other communication under this Agreement shall be in writing and shall be considered given and received when sent by email. The Purchaser's official email for communication shall be deemed the email specified by the Purchaser during the Application for Token Sale. The language of the communication shall be English.

72. Materials, such as Boomstarter White Paper, Road Map and others, published in the Website or elsewhere, are not binding and do not – unless explicitly referred to herein – form part of this Agreement, and are of descriptive nature only.

73. Except as otherwise provided in this Agreement, this Agreement and the rights and obligations of the parties hereunder will be binding upon and inure to the benefit of their respective successors, assigns, heirs, executors, administrators and legal representatives. Company may assign any of its rights and obligations under this Agreement. No other party to this Agreement may assign, whether voluntarily or by operation of law, any of its rights and obligations under this Agreement, except with the prior written consent of the Company.

74. The Purchaser will implement reasonable and appropriate measures designed to secure access to:

74.1. any device associated with the email address associated with the Platform;

74.2. private keys required to access any relevant Ethereum address, and;

74.3. In case the Purchaser suspect a security breach in any of the above mentioned, he will inform Boomstarter immediately so Boomstarter can take all required and possible measures to secure the Website, the Platform, BC Tokens and systems as whole.
